- Acquisition of goods for the constitution of stocks of commercial companies, for export.

industrial export companies, agro-industrial and commercial (businesses registered in the board of trade and corporations), except for the large companies located outside the semi-arid and individual microentrepreneurs, whatever its location, which are not the target audience of this program.
