## SEZ Saryarka

### Decree of the President of the Republic of Kazakhstan "On Establishment of the Special Economic Zone "Saryarka"

Under paragraph 8 Article 7 of the Law of the Republic of Kazakhstan dated July 21, 2011 "On Special Economic Zones in the of Kazakhstan" it is hereby RESOLVED:

1. To establish Special Economic Zone "Saryarka" (hereinafter referred to as "SEZ") for the period until December 1, 2036.
2. To approve the following attached materials:
  1. Regulation on SEZ,
  2. Target indicators of SEZ performance and critical underperformance level

The Government of the Republic of Kazakhstan shall ensure adoption of the following documents:

1. Relevant regulatory legal acts appearing from the present Decree,
2. Other implementation measures of the present Decree.
4. Control over execution of the present Decree shall be assigned to the Administration of the President of the Republic of Kaz
5. The present Decree shall be executed upon its signature.

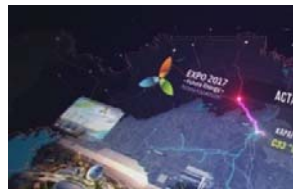
