

Chapter 2

MEAT AND EDIBLE MEAT OFFAL

**Note.**

1. This Chapter does not cover:
  - (a) Products of the kinds described in heading 02.01 to 02.08 or 02.10, unfit or unsuitable for human consumption;
  - (b) Guts, bladders or stomachs of animals (heading 05.04) or animal blood (heading 05.11 or 30.02); or
  - (c) Animal fat, other than products of heading 02.09 (Chapter 15).

**Statistical Note.** (NB This note does not form part of the *Customs Tariff* legislation.)

1. For the purposes of this Chapter, the term "processed" covers meats which have been ground or comminuted, diced or cut into sizes for stew meat or similar uses, rolled and skewered, or specially processed into fancy cuts, special shapes, or otherwise made ready for particular uses by the retail consumer.
